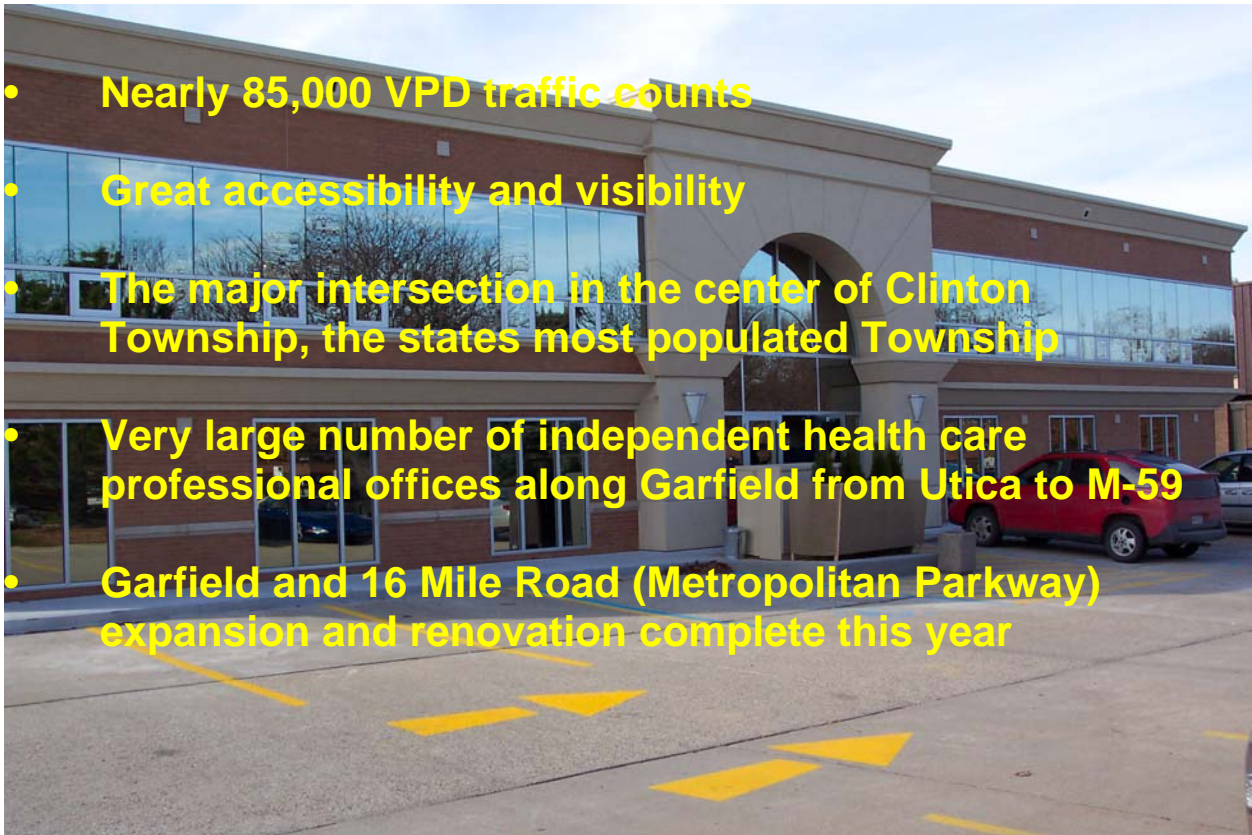


## Holiday Office Buildings
